### **SALE OF STILESVILLE CAMPUS**

As of April 30, 2020 our 1270 Gorge Road property has been sold to the Notre-Dame-de-Joie Mission for \$128,500. After real estate and lawyer's fees, associated disbursements, and HST adjustments, the net proceeds from the sale is \$120,399.87. This has been put into a 'Hub Lease Fund' from which 5% (\$6020) will go to support the Regional Archives, \$20,000 (estimated) for audio-visual expenses at the Community Hub, and the remainder to pay for leasing at the Community Hub, 140 Joyce Avenue, Moncton.

### **COMMUNITY HUB UPDATE**

As the poem goes -

Spring has sprung, the grass is riz. You wondering now where Visions is?

This short update is to inform you "where Visions is". We hoped Visions would be "replanted" in the Joyce Ave. area by this summer. The restrictions around COVID-19 have altered (and might further alter) the timeline for our relocation.

### **Spirit Gatherings/Other programs:**

Our services will continue on-line in August when we return from our summer recess. Eventually, we plan to meet temporarily at the Père Patrice Leblanc Centre, 91 Murphy Ave., just 1 block east of the 140 Joyce Ave. construction site. Your Congregational Leadership Team (CLT) will carefully examine the situation in August and consider public health guidelines, the well-being of our members, and how we can best engage the neighbourhood. We will keep you informed of our plans by September.

140 Joyce Ave. Construction: Preliminary site preparations are complete. Our builder, Windsor Construction, is as eager to resume work, as we all are. Now, we are awaiting the final paper work from the funding sources, which outlines when the money starts flowing to pay the construction bills. Once work is underway we will revise the timeline for completion/occupancy and share it with you.

Hub Planning/Community Engagement: Planning for the Community Hub is starting up, even with pandemic concerns. Operational plans need to be fully in place for when the building is completed. Engaging with the community, Hub staffing requirements, an interim Hub governance plan, an interim management Hub Board, and further partners for this venture are all necessary components. This exciting time is the perfect opportunity for Visions to connect with the neighbourhood and jump into the future. We hope you are as enthusiastic as we are, so stay tuned for your opportunity to participate.

**Point to Ponder:** While we Visions folks are impatient to get "back to normal", this is a very large and complex innovative project, especially in these difficult times. The largest construction project in the Bible was the building of the Ark. Even with God as "Project Manager" navigating the bureaucratic red tape, Noah was 600 years old when it was completed! We promise you will be much younger than that, when our project is completed by us mere mortals...

# VISIONS RECEIVES UCC NEW MINISTRIES GRANT!

Congregational Leadership Team (CLT) is delighted and humbled to announce Visions receipt of a United Church of Canada New Ministries Grant of \$25,000 for June 2020 to May 2021, renewable for two more years for a total of \$75,000. We are delighted because it's a national endorsement of our partnership journey of "Openness" with John Howard Society in creating a Community Hub in Northeast Moncton. We're humbled because ours is the only New Ministries Grant to have been issued this spring for the entire country!

This will help us begin our ministry in the new neighbourhood, plan and participate in community engagement sessions, and develop the Community Hub partnership by covering some of our program costs and a portion of our staff salaries/ time commitment to this work. The Grant obviously makes a major improvement in our 2020 budget (see the financial update this Friday). This grant is an opportunity for Visions to thrive into the future, but is also a serious obligation for us to ensure that this UCC investment in our innovative, community-enhancing project is well-placed.
